HopeWood Outdoors Sets Servant Weekends, 5K Race, Seeks Summer Staff

HopeWood Outdoors – formerly Lutheran Outdoor Ministries of Ohio or LOMO – announces a number of events, volunteer activities and employment openings as the camps, HopeWood Pines (Lutheran Memorial Camp) and HopeWood Shores (Camp Luther), move into spring and then summer.

Both camps have set servant weekends: HopeWood Pines' Servant Weekend is <u>Friday-Sunday</u>, <u>April 25-27</u> while HopeWood Shores' has three servant weekends: <u>Friday-Sunday</u>, <u>May 2-4</u>, <u>May 9-11</u> and <u>May 16-18</u>.

The weekends focus on getting the camp ready for the summer. HopeWood Pines said Servant Weekend projects will include landscaping, painting, cleaning up winter damage and other tasks to help beautify the grounds and facilities. Both note there is no fee for participating in these weekends but freewill donations are accepted to help cover food, insurance and project supplies. <u>Saturday</u>, <u>April 26</u> sees the HopeWood 5K which goes through the pine forest of HopeWood Pines. The run begins at 11 a.m. The \$50 entry fee covers a racer's bib, t-shirt and a finisher's medal. Food will be available at the finish line. Conflict, Peace, and Reconciliation: Lessons from Northern Ireland

Elaine Disbro spent more than a year living and studying in Belfast, Northern Ireland. In December 2024, she graduated with a master's degree in Conflict Transformation and Social Justice. Hear about her experience living in a post-conflict society and what Northern Ireland taught her about conflict, peace, and reconciliation during Redeemer's Adult Education Class on **Sundays, April 6** and **April 13**.

April 6 - Conflict Transformation in Theory and Practice

What is conflict transformation and how does it differ from other approaches that seek to address and resolve conflict? This week the class will explore some of the key theories, concepts, and debates in the field of conflict studies and peacebuilding. "We'll also learn about the conflict in Northern Ireland known as The Troubles and explore the historical grievances, social and economic inequalities, and issues of identity that drove the violence and continue to shape peace and reconciliation efforts."

April 13 - Religion and Peacebuilding in Northern Ireland

Throughout history, religion has been a source of both conflict and peace. In Northern Ireland, where the conflict is often defined by religious identity (Catholic and Protestant), religion has played a complex and paradoxical role, serving as both a source of division and a force for peace and reconciliation. What can we learn from Northern Ireland about the role of religion in conflict and peacebuilding? How might we use these lessons and our Lutheran faith to respond to conflicts facing our world today?

Update from Lutheran Social Services

Kathy Zwanziger reports, that following the news that the Mid-Ohio Food Cooperative would no longer use Redeemer as a site for monthly produce giveaways, Lutheran Social Services' (LSS) **Ben Powers** relayed the following:

"After a period of significant inflation, LSS has actively been cutting costs since October of last year. Unfortunately, that cost containment has not cut expenses enough, and we now had to make the difficult decision to reduce staff across LSS by eight positions. We wanted to let you know that as of Monday, March 24, 2025, **Randi Reid** is unfortunately no longer with the LSS Food Pantries. The decision was not a reflection of her performance, and we thank her for her service and wish her the best.

"Our mission at LSS remains unchanged - we are committed to providing housing, health care and emergency assistance services. Our goal is to strengthen the organization so we can continue to provide critical services to those we serve."

Kathy adds, "As members of Redeemer, we can continue to help our neighbors by serving at the food pantry and helping at First English, contributing to CRIS, the CROP Walk, and the ongoing crisis in Ukraine, as well as supporting other agencies such as Lutheran World Relief, and Lutheran Disaster Response. On a personal level, continue to share God's love by welcoming immigrants into our community."

RLC Commissions BREAD Team

Redeemer commissioned the members of its BREAD Team <u>Sunday, March 30</u> during the 10 a.m. worship service. BREAD – Building Responsibility, Equality, and Dignity -- seeks to further justice issues in this area. These network members – and the congregation – committed themselves to a variety of tasks, including inviting people to the Nehemiah Action, the annual event when BREAD asks public officials to commit themselves to advocating for and implementing BREAD's priorities. Redeemer's Network members include Lynn Belhorn, Michelle Clemence, Michele Disbro, Carol Heacock, Kristi Hildebrand, Julie Johnson, Emily and Nathan Ott, Al Rider, Dave Shull and Kathy Zwanziger.

Kristi reports that, at the Redeemer Justice Network's recent annual meeting, "We started out talking about why we are in BREAD. Some of the comments were the following:

"I can be part of a solution through a bigger effort than I know how to do. I couldn't do this on my own."



"In today's world, you can let yourself get sucked down but maybe by doing something positive, you can get lifted up again. It's a way to act, to get involved, and do something hopeful."

"A song we sing at the Lenten midweek services says 'For justice, for mercy, for freedom, hear our prayer.' Justice, freedom, and mercy don't just happen. We need the Spirit and it requires human hands, hearts, and imaginations to do."

"I was blessed with an upbringing that laid a foundation. Mom did act. I found myself becoming disgusted with things that didn't have equity. I thought, 'Why doesn't someone do something?' And then I said to myself, 'You are the somebody!'"

"As a teacher I saw that parents need a voice. BREAD is a voice that is heard. I enjoy working with people of other faiths and backgrounds. I like being able to address a need and little by little see progress."

The group went over the updates on the two active campaigns, Environmental Justice and Protecting Renters. They also kicked off Nehemiah Action invitation season. It is a once-a-year, 90 minute chance to make a difference just by sitting in a chair. Someone may soon be inviting you to the Nehemiah Action on May 13! (See following article.)

The BIG Gathering

Michele Disbro writes, "You've probably heard reference to 'The BIG Give' for the day when nonprofit organizations hold a big donation day for charitable giving? Well, how about 'The BIG Gathering'? On <u>Tuesday, May 13</u>, the BREAD organization is hoping for a big gathering of people to show support for the campaigns they have been working on this year: a tree campaign for environmental justice and stopping predatory landlords to improve housing issues for many people.

"BREAD has already earned the support of Columbus City Council on both issues and it's time to convince them to take action. ... Numbers truly matter so please mark your calendar to attend the Nehemiah Action at the Celeste Center on **Tuesday, May 13** at 6:40 p.m.

"This is simply a one-time commitment to show up and be in the crowd to show support. Bring a friend or two with you. Let's see if we can meet our goal of 50 people attending the Nehemiah Action. Let's go Redeemer!"

Non-Police Crisis Response Ballot Initiative Moves Ahead

Michele Disbro announced Sunday that the petitions are available for the local ballot initiative to create the non-police crisis response in the city. The goal is to collect 50,000 valid signatures by **Friday, June 27**. Registered voters who live in the city of Columbus can sign the petition. "The benchmark used is if you can vote in the mayoral race, you live in the city of Columbus. If you match this description, please consider signing. We will have them available to sign in the Narthex after church."

Kristi Hildebrand added, "To collect signatures, you only need to be 18 or older. There are no requirements to validate signatures and that can be done from home. If you are interested in collecting signatures or validating signatures, please see **Kristi Hildebrand** or **Michele Disbro**."

DOGE, Trump Administration Cuts Threaten BREAD Trees Initiative

Among the ongoing social justice campaigns that BREAD is pursuing in the community, is encouraging growth of the urban forest in Metro Franklin County, writes **Al Rider**. Central Ohio happens to have one of the thinnest urban forests in the U.S., less than the 40 percent tree cover that is considered a borderline for public health. More trees mean cleaner more breathable air, cooler summers, more birds and wildlife, and measurably lower disease levels. But the Columbus metro area has less tree cover than Brooklyn (!), especially in the more economically-challenged and industrial neighborhoods.

"The city of Columbus actually has adopted a very positive, forward-looking urban forestry <u>plan</u>, and is pursuing it within the city limits, with BREAD's full support. However, the cost-cutting and job-cutting plans of the current White House and DOGE team have called this into question. Executive Order No. 14154 titled "Unleashing American Energy" threatens to impound over \$1 trillion appropriated by Congress under the Inflation Reduction Act of 2022 and the Infrastructure Investment and Jobs Act of 2021."

The Ohio Department of Natural Resources was awarded nearly \$5.5 million for 36 urban forestry projects in the state last year. Columbus received a \$500,000 grant, and in 2024 spent \$394,000 planting 1,250 trees in underserved neighborhoods -- expecting reimbursement by the federal government. But following the executive order, Columbus' Rec and Parks Department was informed that reimbursement would not be coming as promised. As a result, the rest of the program is on hold, since funding is now in question.



The city of Columbus has joined over a dozen plaintiffs filing a lawsuit in U.S. District Court alleging the executive order "...unlawfully def(ies) Congressional mandates by freezing, disrupting, and terminating funds that Congress had directed and appropriated to specific grant programs to benefit the environment."

Anyone living within city limits is encouraged to call or message their City Council members to support this environmental program and their members of Congress, "on behalf of a shadier, healthier metro area for all of us."

Special Funds Team Provides Overview

John Kennedy, treasurer on the Special Funds Team (SFT) at RLC, writes, "The SFT wanted to provide you with an update on RLC special funds as of the close of 2024.

"We have four funds at RLC that the SFT is chartered to monitor. The monies in the first three funds are placed with the Columbus Foundation and invested with their advice and consultation under Redeemer's direction. In no particular order, here is a brief overview, and then the End of Year (EOY) 2024 status, of each fund.

Mary Kohler Ministry Fund

Highlights

- An unrestricted bequest from Mary Kohler, a teacher and RLC member, and a gift from an anonymous donor established the fund.
- Principal and earnings may be distributed.
- Applications for educational purposes and for new or existing RLC neighborhood ministries receive priority, honoring the donor's intent.
- Members may recommend uses of this fund to the SFT at any time.

- Following consultation with the family, the SFT recommends to the Congregation Council a use for the funds.
- The recording of that Memorial is concluded upon expenditure of those funds.
- Because of the purpose of this fund, the monies shall remain liquid and not be considered for long-term investment.

Considering Ways to Support Immigrants

Church Council has appointed **Julie Johnson** to lead a new ministry group to explore ways Redeemer can support those seeking to immigrate legally to or to remain legally in the United States. People on this ministry group include **Elaine Disbro, Kelley Frank, Emily Ott, Karen Rider** and **Dave Shull**.

The ELCA is a "Sanctuary Denomination." As the ELCA website states: "In its simplest form, becoming a sanctuary denomination means that the ELCA is publicly declaring that walking alongside immigrants and refugees is a matter of faith."

Among the tasks the ministry group has identified are the following:

- > Keeping informed of the rapid changes affecting specific refugee and immigrant groups initiated by the Trump administration.
- ➤ Keeping informed of the legal actions and the status of those actions.
- > Ensuring that those we know who are potentially affected have access to resources to help them.
- Learning about the various ways that Redeemer can consider how to be a sanctuary to immigrants and refugees.
- Learning what churches in our area are doing and have done to support immigrants and refugees.
- > Exploring what the implications and factors would be in considering all of the options that we might be called upon to consider.
- Reporting our findings to the Congregation Council.

"One immediate way that individuals and Redeemer can walk along with immigrants at this critical time is by supporting CRIS Ohio. The Community Refugee and Immigration Services (CRIS) is a nonprofit agency in Central Ohio that provides a variety of services to refugees and immigrants. "The quickest way to support CRIS is directly through either their website at crisohio.org or by calling 614-235-5747. You can also donate by writing a check to Redeemer and note in the memo line CRIS. Donations through Redeemer are usually delayed by at least a month.

"Another way that Redeemer is walking alongside immigrants is to be of assistance to those who worship with us. Whether through transportation to church, providing a bulletin in their language, connecting them to needed services or helping with daily needs, we have opportunities to help."

We ask for your prayers as we continue in this work.

ELCA Issues Draft Statement on Child Protection/Maltreatment

The ELCA released a <u>draft social message</u> on child protection and maltreatment on March 21, ELCA Program Director of Theological Ethics, Education and Community Engagement Ryan Cumming and ELCA Director of Theological Ethics Roger Willer announced. This draft social message is in response to a request from the 2022 ELCA Churchwide Assembly and addresses the church's calling to protect and nurture children and youth, both within the church and within society more broadly. We are writing in hope that you will participate in the public comment period on this draft.

Folks are asked to read the draft social message and complete an online survey by visiting <u>HERE</u>. Comments, affirmations, questions or concerns about the draft social message can also be emailed to the Theological Ethics team of the



ELCA churchwide organization at <u>draftsocialmessage@elca.org</u>. The survey and public comment period will be open until **Monday, June 30**. A copy of the draft can also be found on the kiosk in the Narthex.

ELCA social teachings are developed through a process of communal deliberation across the church, and your feedback will be prayerfully considered as this draft is revised. Your perspective is important to this process, so we hope you will find time to review the draft and share your comments.

A revised, proposed social message will be sent to the ELCA Church Council this fall for possible adoption as the newest social teaching of our church. If adopted, this social message will serve as a guide for people of faith to think theologically and ethically about children and the church. It will also serve as an official policy document to guide the church's public witness and to support policies at the congregational, synodical and churchwide level.

Prayer Concerns from ELCA

April 1 Pray for lasting peace between nations and for the healing of people who suffer conflict, war and violence, especially in Ukraine, Russia, Gaza, Israel, Syria, Haiti, Myanmar and regions of Africa.

- **2 Arab American Heritage Month** Give thanks for the contributions and impact of Arab Americans in every aspect of society, including religion, education, science, business, government and the arts. Ask God to bless and further the work of ELCA Arab and Middle Eastern Ministries and the Association of Lutherans of Arab and Middle Eastern Heritage.
- **3** "You have come down to the lakeshore seeking neither the wise nor the wealthy, but only asking for me to follow" (*WOV* 784). Praise God for seeking us out and, despite our imperfection, making us humble disciples, equipped and inspired by the Spirit.
- 4 Pray for church leaders, liturgists, scholars and scientists gathering to discuss including the Feast of Creation Day in liturgical calendars, an effort organized by the Roman Catholic Church in partnership with the Lutheran World Federation, World Council of Churches, World Methodist Council, Anglican Communion and World Communion of Reformed Churches. Ask the Spirit to guide their study and discussion of climate justice, the Nicene Creed, the role of the Holy Trinity in creation, and how Christians engage with the creation story.
- **5** Remember in prayer worship leaders and musicians participating in the ecumenical Music that Makes Community workshop in Waco, Texas, a day of building community through singing, learning and fellowship.
- **6** Pray for a spirit of humble generosity that recognizes and encourages the diverse gifts and contributions of our siblings in Christ, who give as they are able and are inspired by their gratitude towards and love for God.
- 7 Praise the Creator for the new life of an emerging spring, which inspires our joy, awe and hope.

The Community Beyond

April 7 Deadline to Register to Vote in May Primary

Next Monday, April 7 is the deadline to register to vote in the Primary Election set for <u>Tuesday, May 6</u>. To be qualified to vote, an individual must meet the following requirements:

- Be a citizen of the United States.
- Be at least 18 years old on or before the day of the general election in November.
- Be a resident of Ohio for at least 30 days immediately before the election they want to vote in.
- Not be incarcerated for a felony conviction or have been declared incompetent for voting or permanently disenfranchised.

Also required is an Ohio driver's license or state ID card and the last four digits of the voter's Social Security number. Registration can be done online <u>HERE</u>. Address changes can also be handled online.

Candidates on the Franklin County May ballot are those running for seats on the Columbus City Council, Whitehall City Council, Hilliard City Council and the Columbus Board of Education. Eligibility to vote for these depends on an individual's address.

Free Tax Prep Service Serves Low- to Moderate-Income Households

With the annual tax filing deadline quickly approaching, Franklin County is raising awareness about free tax preparation services available to thousands of residents and families. The Franklin County Board of Commissioners recently highlighted the Tax Time program, which serves low- to moderate-income households.

Earlier this year, the commissioners approved a contract between the Franklin County Department of Family Services and the United Way of Central Ohio, providing \$75,000 in funding for Tax Time, a coalition of nonprofit, business, and government partners that aims to help residents maximize their returns, avoid preparation fees, and build wealth.

"As a former Tax Time volunteer, I have seen firsthand the tremendous impact this program has on our community," said **Board President Commissioner Erica C. Crawley**. "This initiative not only empowers our residents to maximize



their tax returns, ensuring they receive every dollar they are entitled to, but it also safeguards them from costly and potentially predatory tax preparation services that can take advantage of those who may not be aware of their options."

Tax Time brings together the United Way's Volunteer Income Tax Assistance (VITA) program and AARP's Tax Counseling for the Elderly program under one comprehensive initiative. This tax season, residents can access free tax preparation services both in person and virtually at multiple locations across Franklin County.

"We encourage all residents to take full advantage of this service," **Commissioner John O'Grady** said. "Every effort has been made to ensure accessibility, whether you prefer to meet with volunteers in person or simply find virtual support more convenient."

Tax Time has prepared and processed more than 189,000 tax returns since its inception in 2007. Tax Time's IRS-certified volunteers prioritize helping families claim their full refunds, including credits such as the Child Tax Credit and the Earned Income Tax Credit

"Ensuring that every eligible resident can access free, high-quality tax preparation is a vital step toward financial empowerment," said **Commissioner Kevin L. Boyce**. "Tax Time helps families keep more of their hard-earned money, avoid costly fees, and claim the credits they deserve. This program is about strengthening financial futures and safeguarding economic stability for all our neighbors."

Households, earning less than \$67,000 last year are eligible for free preparation services. **United Way Program and Grants Coordinator Brandi Cunningham** reported that Tax Time has helped more than 2,000 in Franklin County this season.
